



Notice of Special Resolution

The Executive Committee proposes the following changes to the Constitution of the Australian Injury Prevention Network (Inc) and seeks the endorsement of the AIPN membership for these changes.

The reasons for proposing the changes are to enable the organisation to have a more active presence within the Australasian region and to accept as members, individuals and organisations who reside in jurisdictions other than Australia.

The Executive Committee seeks the endorsement of the AIPN membership to:

1. Broaden the focus and reach of the organisation to the Australasian Region
2. Change the name of the organisation from Australian Injury Prevention Network to Australasian Injury Prevention Network
3. Amend the following clauses in the constitution

1. NAME

The name of the Incorporated Association is the Australasian Injury Prevention Network.

2. INTERPRETATION

- 2.1. In these Rules, unless the contrary intention appears

"Association" means the Australasian Injury Prevention Network Incorporated;

3. OBJECTS

- 3.1. To advance the knowledge and practise of the prevention of injury ~~at local, state and national and regional levels~~ in the Australasian region by
- (e) Drawing on the strengths of the multiplicity of approaches to the prevention of injury including public health, transport, occupational health and safety, ~~local all levels of~~ government and of the justice sector and promoting the transfer of knowledge between the many disciplines of safety.
 - (f) Advocating for the development and implementation of appropriate injury prevention legislation, policies, practises and programs at local, State and national ~~and regional~~ levels within the Australasian region.
 - (j) Organising regular scientific conferences at ~~a national~~ the Australasian regional level.

(k) Representing and advocating for Injury Prevention as a ~~an national-regional-Australasian regional~~ non-government organisation.

(l) To be the peak organization for injury prevention in Australasia.

(q) carry out anyone or more of those objects independently or exclusively of the remaining objects in any part of Australasia or elsewhere.

4. MEMBERSHIP

4.3. Where a member is an Organisation, it may from time to time appoint one delegate, and each such delegate shall have the powers, rights and privileges of attending, speaking, being elected to chair and voting at meetings and of nominating other persons for election or being nominated ~~or~~ and elected as an Elected Officer or member of the Committee as if the delegate were the member.

6. BRANCHES

6.1. Members ~~resident within any State or Territory of Australia~~ may with the consent of the Committee establish a branch of the Association in ~~that State or Territory~~ their state, territory or jurisdiction within the Australasian region.

7. ELECTED OFFICERS

7.1. From the members of the Association the following officers shall be selected –

a) a President;

b) a Treasurer;

c) a Secretary;

d) ~~a two~~ persons representing the views and concerns of indigenous peoples (one Aboriginal or Torres Strait Islander ~~people~~ and one Maori); and

e) six other members as decided at the annual general meeting. *[Amended 2012]*

f) at least one elected officer must reside in New Zealand or other jurisdiction in the Australasian region

7.6. Where possible, ~~representation on~~ the committee should represent a mix of members from different ~~States and Territories~~ states, territories and jurisdictions within the Australasian region with a minimum of four jurisdictions. *[Amended 2013]*
